

These samples were dissolved totally by pre-conditioning method according to below flow chart.





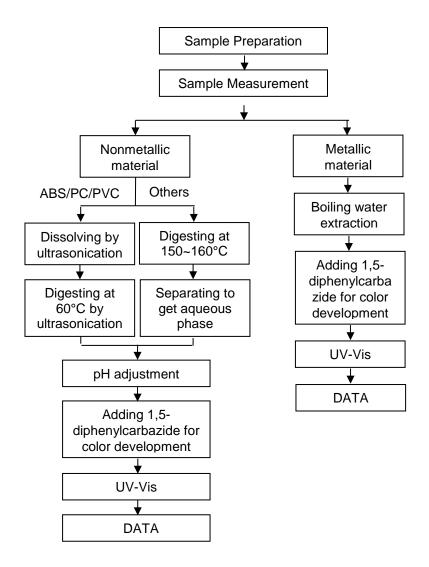



### PBBs/PBDEs Testing Flow Chart







#### **Phthalates Testing Flow Chart**






