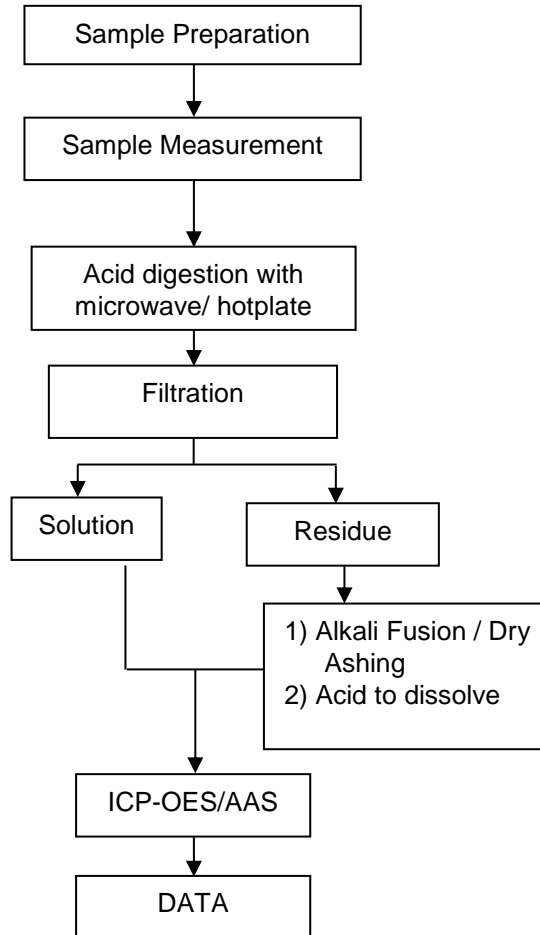

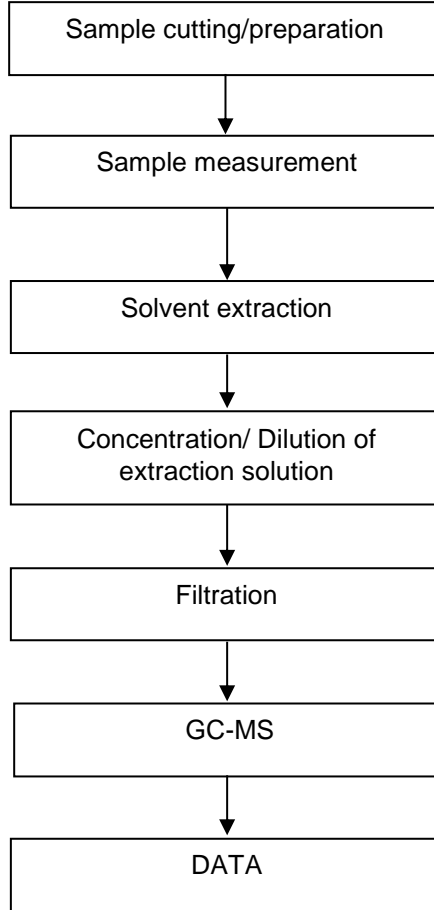
Hexavalent Chromium (Cr(VI)) Testing Flow Chart



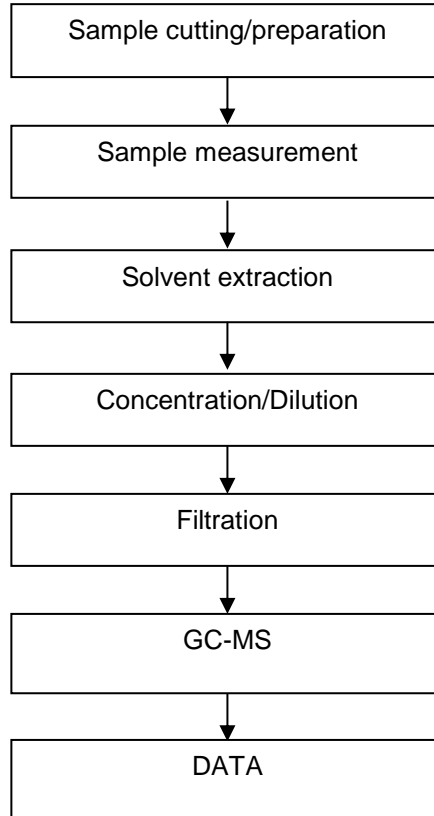

### PBBs/PBDEs Testing Flow Chart

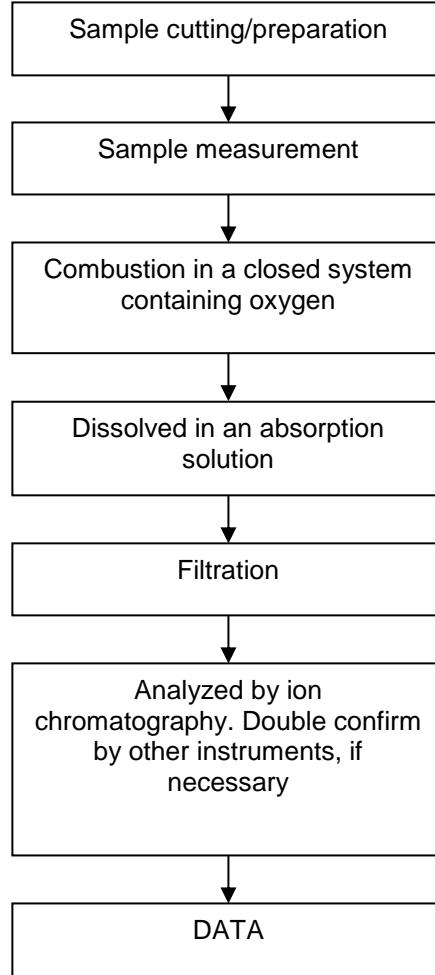


### Phthalates Testing Flow Chart

## Halogen Testing Flow Chart





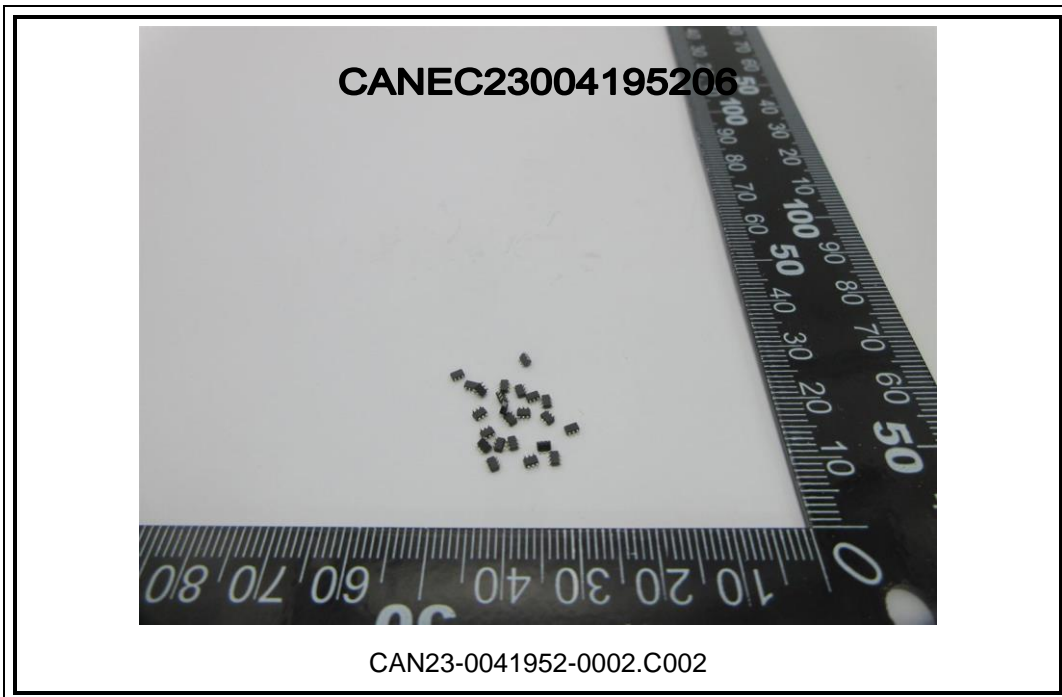
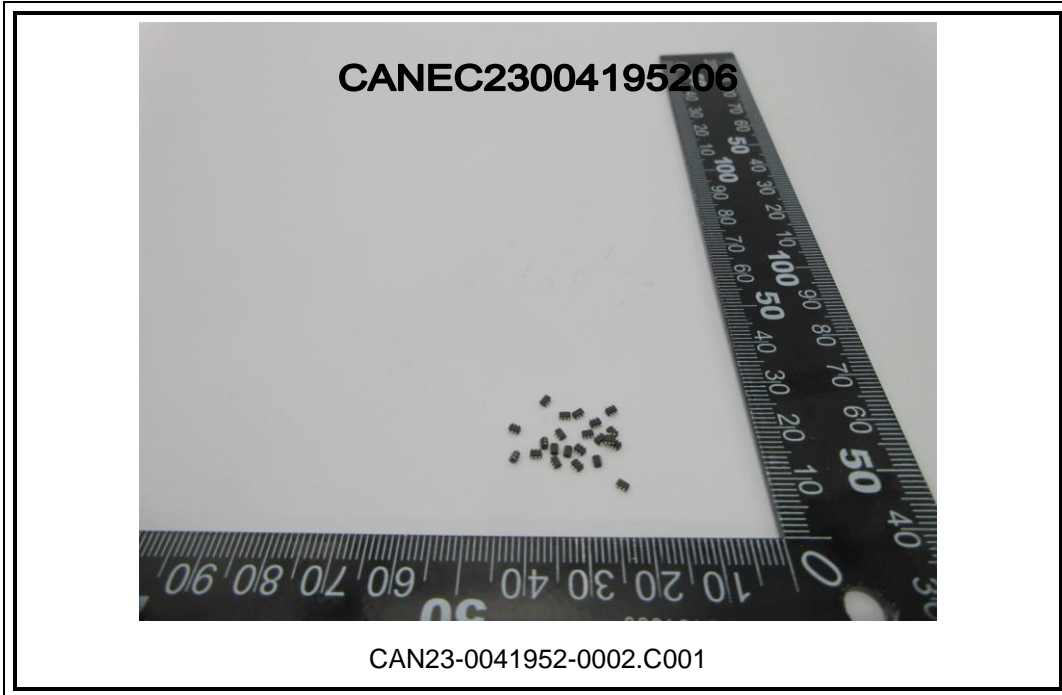
