Halogen Testing Flow Chart



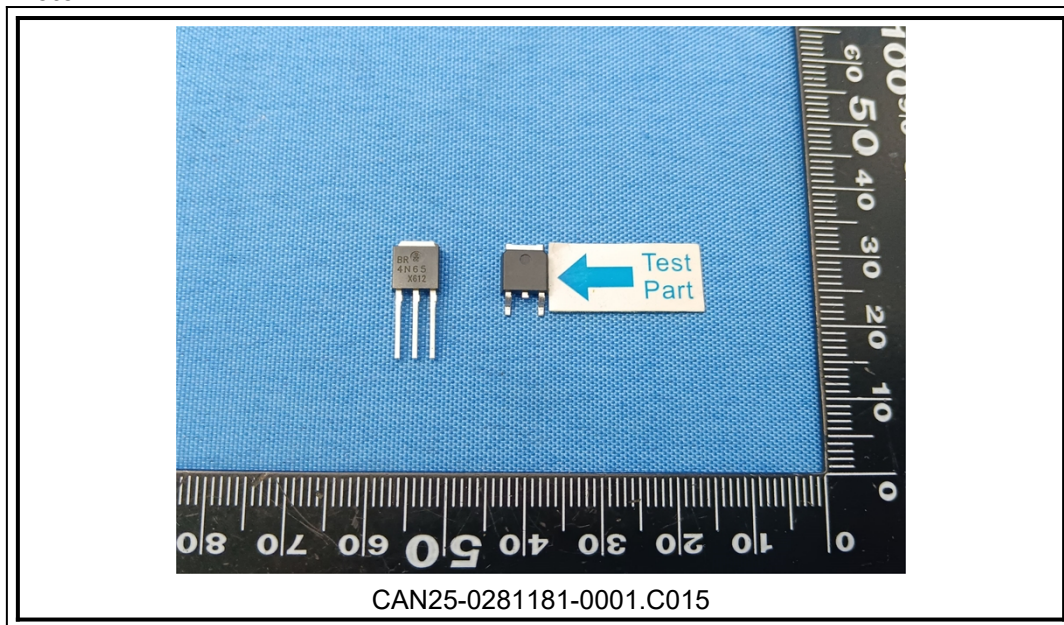
